1. Students have to fill up, the college admission form ONLINE on the link – i.e. <https://enrollonline.co.in/Registration/Apply/res> as well as University registration form as per University guidelines to be filled on website – i.e. <http://muugadmission.samarth.edu.in> link.
2. They must fill the details of name, percentage, category, no. of attempts and year of passing, properly, as per the norms prescribed by the University of Mumbai.
3. Students who have passed HSC examination in **more than one attempt**, they should fill their percentage as **35%** only.
4. They should see the “Merit List” displayed as per the “schedule of admission” and if their name appears in Merit List then take print out of University of Mumbai Registration and Rizvi College admission form and secure your seat by paying the fees ONLINE, along with DECLARATION / UNIVERSITY form, from the Student to be Uploaded
5. Students are directed to check our college Prospectus and website for the subject combination and till accordingly in admission and enrollment form.
