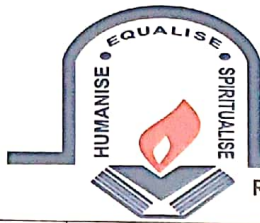

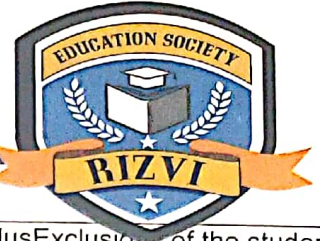

B	Smuggling in or written answer book based on the question paper set at the examination.	Punishment of Sr. No.1 plusExclusions of the student from University or College or Institution examination for three additional examinations.
C	Smuggling in or written answer book based and forging signature of the Jr. Supervisor thereon.	Punishment of Sr. No.1 plusExclusions of the student from University or College or Institution examination for four additional examinations.
05	Attempt to forge the signature of the Supervisor on the answer book or supplement	Punishment of Sr. No.1 plusExclusions of the student from University or College or Institution examination for four additional examinations.
06	Perferring with or counterfeiting of University/ College/InstitutionSeal , or answerbooks or office stationary used for examination	Punishment of Sr. No.1 plusExclusions of the student from University or College or Institution examination for four additional examinations.
07	Answer book main or Supplement written bothside the examination hall or any other portion in answerbook	Punishment of Sr. No.1 plusExclusions of the student from University or College or Institution examination for four additional examinations.
08	Portion of Currency notes/ to bribe or attempting to bribe andy of the persons expected with the condut of the examination	Punishment of Sr. No 1 plusExclusions of the student from University or College or Institution examination for four additional examinations.

11	Impersonation by a University/College/Institute student at ssc/HSC any other examination	Punishment of Sr. No. 1 plus Exclusion of the impersonator from University or College or Institution examination for five additional examinations.
12	Revealing Identity in any form in the answer written or in any other part of the answer book by the students. At the University/college/ Institute examination.	Annulment of Performance of the student of the University/ college/ Institution examination in full
13	Found having written on Palms or on body or on the cloths while in examination .	Annulment of Performance of the student of the University/ College/ Institution examination in full
14	All other Malpractices not covered in aforesaid category	Annulment of Performance of the student of the University/ College/ Institution examination in full and saver punishment depending upon the gravity of the offence.
15	If on previous occasion or disciplinary action was taken against a student for mal practices used at examination and he/she is caught against for malpractices used at the examination, in these event he/she shall be dealt with severely. Enhanced punishment can be imposed on such student. These enhanced punishment may extend to double the punishment provided for the offence. When committed at the second or subsequent examination.	
16	The Competent Authority in addition to the above mentioned punishment may imposed a fine on the student declared Guilty.
